All credit applications will be subject to trade reference verifications.

There is a \$500 minimum monthly charge on all commercial accounts. If this threshold is not met for two (2) consecutive months, the account may be closed at the discretion of NTMWD.

Invoices are issued around the 1st of the month and payment is due within 30 days of the date of invoice. Please consider mailing times, as the District is not responsible for Post Office delays.

In the event payment is not made by the due date, the account will be suspended until the account balance is paid in full. BE ADVISED: Two (2) late payments in a 12-month period could result in permanent account suspension. While the account is suspended, you may NOT use the landfill or transfer stations.
